# HSTP Update: Background

- ◆ Addresses the transportation needs of:
  - Elderly and young
  - People with disabilities
  - Low income
  - Rural residents unable to provide their own transportation
- ◆ Federal and state transportation planning requirement; 4 yr. update
- ◆ Supports applications for:
  - WSDOT's Biennial Public Transportation Consolidated Grant Program
  - FTA Section 5310 funds received by C-TRAN



# Human Services Transportation Plan: Background

## Requirement:

- ◆ Federal and WSDOT requirement

## Plan Elements (established by WSDOT):

- ◆ Coordinate with stakeholders
- ◆ Gather data and information
- ◆ Address emergency management
- ◆ Identify unmet transportation needs
- ◆ Develop strategies to meet public transportation needs

- ◆ Maintain Existing Service
- ◆ Address Deficiencies
- ◆ Provide Community Benefit
- ◆ Community Connections
- ◆ Financial Partnerships
- ◆ Support Coordination
